I. Payments and Billing:

- A. Commercial credit terms are available to established businesses. To be eligible for the terms listed below, an up to date, approved credit application must be on file and accepted by *Discover Trading Company Inc.*
- B. Terms: Invoices will be sent promptly. Payment is due within 30 days of the invoice date.
 - 1. Payments received after 60 days will incur a 1.0% fee per month beyond the 60 days. Future credit deliveries will be suspended until an acceptable payment arrangement has been made.
 - 2. Payments not received within 120 days of the invoice date will continue to incur a 1.0% fee per month and be considered delinquent.

II. Warranty:

- A. **Twelve months from date of retail sale or 18 months from the date the unit was delivered to you, whichever comes first:** All Discover Trading Company products are manufactured to our high standards for quality control. However, should a product become defective due to a flaw incurred during the manufacture of the product, or should the material be found to be defective within the above listed time frame, contact us for free product repair or replacement, subject to our confirmation and final decision. Warranty does not cover damage caused by misuse, abuse, items subjected to frost damage, incorrect installation, incorrect application or shipping damage.
